ARE HUMAN BUT WITHOUT HUMAN RIGHTS WHY?

1. In Indian illegally occupied Jammu and Kashmir, Indian troops in their fresh act of state terrorism martyred one more Kashmiri youth in Baramulla district, today, raising the toll to two in the past 24 hours.
2. The troops martyred the youth during a cordon and search operation in Wanigam Bala area of the district. Another youth was martyred by the troops in the same area, last night.
3. Sadly, the Indian media flashed the news about the elimination of an Indian army dog, Axel, during the operation under banner headlines, but uttered no words of sympathy for the martyred Kashmiri youth. The media covered the wreath-laying ceremony of the slain dog by the Indian army at the headquarters of 10 Sector Rashtriya Rifles with every minute detail with how top Indian army leadership including Maj. Gen. SS Slaria, General Officer Commanding Kilo and representatives of the Indian Police attending the event without any shame.
4. The locals condemned both the Indian media as well as the army for glamorizing the killing of the dog, but maintaining a criminal silence on the massacre of Kashmiri youth in fake encounters. They said that the occupation troops had martyred thousands of Kashmiris in IIOJK in the past three decades without any reason, but the morally-bankrupt Godi media did not pay heed to these killings as if the life of an animal is more important than the life of Kashmiri people in the eye of the Indian media.
5. Senior APHC-AJK leader Muhammad Farooq Rehmani in a statement in Islamabad urged the United Nations Human Rights Council and other concerned groups to urgently intervene in the face of deteriorating health condition of Hurriyat leader Muhammad Yasin Malik in Tihar jail. Malik is on a hunger strike till indefinite period since July 22. Farooq Rehmani supported Yasin Malik's demand for fair trial.
6. Meanwhile, the culture of killing of innocent people by Indian troops in fake encounters in IIOJK has started spreading its ugly tentacles deep inside India under Modi-led fascist government. In one such latest development, thirteen Indian police personnel, including a superintendent of police, have been booked for abducting a fellow countryman Bhalchandra and subsequently killing him in a fake encounter in Chitrakoot area of Uttar Pradesh state in March 2021.
7. On the other hand, Chief Justice of India N V Ramana addressing an event in New Delhi admitted that only a small percentage of the population could approach courts while the majority suffers in silence in India.

1. In Indian illegally occupied Jammu and Kashmir, Indian troops in their fresh act of state terrorism martyred one Kashmiri youth in Baramulla district, today. The troops martyred the youth during a cordon and search operation in Wanigam Bala area of the district. Earlier, two Indian soldiers and one policeman were injured in an attack in the same area. The operation continued till last reports came in.
 2. The All Parties Hurriyat Conference General Secretary, Molvi Bashir Ahmad Irfani, in a statement issued in Srinagar said the RSS-backed Modi government, Indian army, judiciary and all other institutions have waged a war against the oppressed Kashmiris and they are hell bent to impose the Hindutva ideology in IIOJK. He said India's oppressive tactics and conspiracies have failed to suppress the Kashmiris' freedom movement in the past and will meet the same fate in the future as well.
 3. The occupation authorities booked an unlawfully detained youth, Rishab Butt, under black law, Public Safety Act, in Jammu. Rishab Butt was arrested by the Indian police on 14th of this month and is presently lodged at Kot Bhalwal Jail in Jammu.
 4. An Indian soldier was detained at the Srinagar Airport today after security personnel recovered live rounds and a teargas shell from his baggage. Two Indian troops were also arrested at the airport, yesterday, after recovery of live rounds from their luggage.
 5. The brutal Indian authorities shifted back the illegally detained Kashmiri Hurriyat leader, Muhammad Yasin Malik, from a hospital to infamous Tihar Jail in New Delhi. Yasin Malik was admitted to the hospital on Tuesday after his health condition deteriorated in the jail where he was on an indefinite hunger strike. He is on hunger strike since July 22 in protest against the denial of fair trial in the false cases registered against him.
 6. The authorities in the Indian state of Uttar Pradesh have booked five Muslims under draconian laws for taking part in the protest demonstrations in Beckonganj area of Kanpur city against derogatory remarks by BJP leader Nupur Sharma about Prophet Muhammad (peace be upon him), last month. The authorities slapped National Security Act on Hayat Zafar Hashmi and the Gangsters Act on Mukhtar Ahmad Baba, Haji Muhammad Wasi, Akeel Khichdi and Shafiq in the case registered over the protests on June 03.

1. In Indian illegally occupied Jammu and Kashmir, the All Parties Hurriyat Conference has called for complete shutdown and large-scale protest demonstrations on 5th August in the territory and urged the people to offer special prayers for the success of the ongoing freedom movement.
 2. APHC General Secretary, Molvi Bashir Ahmad Irfani in a statement issued in Srinagar appealed to the Kashmiris living in Azad Jammu and Kashmir, Pakistan and the world over to hold protest rallies to draw attention of the international community towards the Indian brutalities in IIOJK. He said that the Kashmiris would observe 5th August as Black Day and Youm-e-Istehsaal to give a clear message to India that they reject its illegal occupation of their homeland and are determined to continue their freedom struggle till complete success. On 5th August 2019, Narendra Modi-led fascist Indian government repealed the special status of IIOJK and put it under strict military siege.
 3. On the other hand, Narendra Modi's Hindutva regime attached the houses of five more persons in Srinagar to punish them for their affiliation with the ongoing freedom movement. The Indian authorities have already attached properties of several Kashmiris over the last few months. Besides attaching properties on one pretext or another, Indian troops are regularly destroying residential houses in IIOJK during violent military operations to render the Kashmiri people homeless.
 4. The Modi regime as part of its nefarious designs to Indianise the occupied Jammu and Kashmir has renamed eighteen educational institutions after the Indian forces' personnel who were killed in various attacks in the territory. The motive behind the move is to erase the Muslim identity of IIOJK.
 5. Two Indian soldiers were held at the Srinagar airport, today, after the airport security personnel recovered live rounds from their baggage.
 6. On the other hand, a 15-year-old Muslim student was locked in a room and beaten to death by three Hindu teachers at a private school in Kannauj city in the Indian state of Uttar Pradesh. Upper caste Hindus attempted to strip a 38-year-old Dalit woman in Aligarh district of the same state.

1. In Indian illegally occupied Jammu and Kashmir, senior leader of All Parties Hurriyat Conference, Mirwaiz Umar Farooq, has expressed serious concern over the deteriorating health of illegally detained Chairman of Jammu and Kashmir Liberation Front, Muhammad Yasin Malik, in New Delhi.
2. Muhammad Yasin Malik who is on an indefinite hunger strike since Friday has been shifted to a Delhi hospital after his health worsened in Tihar Jail, the other day.
3. The Mirwaiz in a statement in Srinagar demanded provision of medical assistance to the ailing jailed leader on emergency basis. He said the Kashmiri leaders are subjected to vengeance for their political beliefs. However, he made it clear that repression on the basis of political ideologies can neither change the facts on Kashmir nor sentiments of the Kashmiri people. He maintained that ultimately dialogue between all stakeholders will be the only way to resolve the long-standing Kashmir dispute on a permanent basis.
4. The incarcerated APHC Vice Chairman, Ghulam Ahmad Gulzar, in a special message from Srinagar Central Jail said the Kashmiris will always observe August 5 as Exploitation Day, day of mourning and a black day. He said that the RSS-backed fascist government led by killer of humanity Narendra Modi usurped political, social and religious rights of Kashmiris and 5 August 2019 action was a direct attack on Kashmir's unique identity, culture, employment, demography and basic fundamental rights by Hindutva forces.
5. Peoples Democratic Party President Mehbooba Mufti addressing a function in Srinagar, today, praised Pakistan and China over the China-Pakistan Economic Corridor project and called for declaring the occupied Jammu and Kashmir and Azad Jammu and Kashmir as a world peace zone. She asked India for connecting IIOJK with the world in the same manner Pakistan and China are connecting the AJK. Mehbooba appealed to the Indian prime minister to order release of all Kashmiri detainees languishing in different jails.
6. Indian government has admitted that two Kashmiri journalists have been detained by Indian police under the black law Public Safety Act in IIOJK, this year. Indian Minister of State for Home Nityanand Rai said this while replying to a question in Rajya Sabha, the upper house of Indian Parliament.
7. Landslides, stone-shooting, washing away of roads and bridges triggered by heavy downpours led to the closure of Srinagar-Jammu highway and Srinagar-Leh highway at various places in occupied Jammu and Kashmir, today.

1. In Indian illegally occupied Jammu and Kashmir, the All Parties Hurriyat Conference has deplored that Narendra Modi-led fascist Indian government is subjecting the illegally detained Kashmiri Hurriyat leaders to vengeance for challenging India's illegal occupation of their homeland.
2. The APHC in a statement in Srinagar strongly denounced the continued illegal detention of Hurriyat leaders Masarrat Aalam Butt, Shabbir Ahmad Shah, Muhammad Yasin Malik, Aasiya Andrabi, Nayeem Ahmad Khan, Altaf Ahmad Shah, Ayaz Muhammad Akbar, Peer Saifullah, Raja Merajuddin Kalwal, Farooq Ahmad Dar and Shahid-ul-Islam. It said the denial of basic facilities including proper medical care and hygienic food in the jail has taken a heavy toll on the health of these leaders. However, the APHC said the worst Indian atrocities have failed to force the Hurriyat leaders to give up their just cause and they are determined to spearhead the ongoing freedom movement till it reaches its logical conclusion.
3. The Jammu and Kashmir Democratic Freedom Party in a statement in Srinagar said that by facing the continued illegal detention with resolve, its Chairman Shabbir Ahmad Shah is scripting a new history of resistance against Indian occupation of Jammu and Kashmir. It said in his 67 years life, Shabbir Shah has to spend 36 years in prisons, detention and interrogation centers within and outside the Kashmir Valley because of his political beliefs.
4. Indian troops launched a cordon and search operation in Brayihard Kathpora area of Kulgam district, today. An Indian soldier was critically injured in an attack in the same area during the operation.
5. Kashmiri journalist Aakash Hassan in a tweet said that Immigration officials at New Delhi Airport barred him from boarding a flight to Colombo, Sri Lanka, without giving him any reason. Aakash said that he was headed to report on the current situation in Sri Lanka.
6. The APHC-AJK Convener, Mahmood Ahmad Saghar, and senior leader Altaf Hussain Wani in their statements in Islamabad expressed serious concern about the declining health of illegally detained Jammu and Kashmir Liberation Front Chairman, Muhammad Yasin Malik. The JKLF chief was shifted to a hospital, yesterday, after his condition deteriorated in New Delhi's infamous Tihar Jail where he was on an indefinite hunger strike since Friday against the unfair trial in the cases registered against him.

1. Kashmiri Hurriyat leader Mohammad Yasin Malik, who is on a hunger strike in New Delhi's infamous Tihar Jail since Friday, has been put on intravenous fluid by the jail authorities.
 2. The decision in this regard was made after Yasin Malik's health deteriorated in jail last night. As per Indian media reports, Yasin Malik is severely dehydrated and he needs to be shifted to the hospital for treatment. Yasin Malik, sentenced by a special court of India's dreaded National Investigation Agency in Delhi this year to two lifers on fake charges, had stopped eating food on July 22 saying that trial of his case was not being carried out on merit. Senior jail officials at Tihar confirmed that they met Yasin Malik and tried to convince him to end his strike, but he refused.
 3. In Indian illegally occupied Jammu and Kashmir, strong resistance by the local population has put the Modi-led Indian regime on the back foot vis-à-vis its 'Har Ghar Tiranga' campaign, launched to force every Kashmiri to buy Indian flag for Independence Day celebrations. Earlier, people in the Kashmir valley were asked through loudspeakers to Pay Rs20 for 'Har Ghar Tiranga' campaign launched by the Modi regime in the territory. However, on facing stiff resistance, the Indian authorities tried to hide their embarrassment by saying that the notification in that regard was "issued erroneously" and "the contribution was voluntary".
 4. A series of protests against the anti-people policies of the BJP-led Hindutva regime were held in parts of Jammu region, today. People from Thannamandi town and adjoining areas assembled at Shahdara Chowk, blocked the main road and raised slogans against the occupation regime for its apathy towards the sufferings of the Kashmiri people. Another protest was organized by Jammu-based employees at Ambedkar Chowk Park in the city.
 5. Congress leader Rahul Gandhi along with 17 other Congress MPs was detained at Vijay Chowk in New Delhi, today, as he was leading a sit-in protest against the Enforcement Directorate questioning party chief, Sonia Gandhi. Before his arrest, he said India under Modi government has become a police state.
 6. In another development, 19 Congress members of Rajya Sabha, the upper house of Indian parliament, were suspended, today, for protests against Modi government over inflation. Earlier on Monday, Lok Sabha Speaker Om Prakash Birla suspended four Congress Members on the same issue.

1. The All Parties Hurriyat Conference has strongly condemned the brutalization of Kashmiri youth in the garb of relentless cordon and search operations by Indian troops in nook and corner of occupied Jammu and Kashmir.
 2. The APHC leadership in a statement issued in Srinagar said the rapidly changing realities in the region warrant an immediate intervention by the international community to resolve the Kashmir dispute as per UN resolutions. The leadership condemned the cruel laws, employed by the Modi regime in IIOJK to punish the Kashmiri people for demanding the right to self-determination.
 3. Families of several youth illegally detained by India this year under draconian Public Safety Act have revealed that their kin had gone incommunicado after being shifted from IIOJK to outside jails in India. Some hapless families have decided to knock the doors of the Indian Supreme Court to trace the whereabouts of their dear ones. Syed Musaib, a lawyer in IIOJK High Court, said an order from the India's apex court to the respondents would be sought to ensure that the families could access to the youth, detained at undisclosed locations.
 4. Peoples Democratic President Mehbooba Mufti in her tweets in Srinagar lashed out at the outgoing Indian president, Ram Nath Kovind, for being instrumental in fulfilling the BJP's political agenda. She mentioned the scrapping of Article 370, the enacting of Citizenship Amendment Act and the targeting of minorities as some of major crimes wherein Ram Nath Kovind colluded with the ruling BJP in India. She also condemned the Modi government for forcing Kashmiri people to buy the Indian flag ahead of its Independence Day on August 15.
 5. An Indian Border Security Force sub-inspector committed suicide by shooting himself with his service rifle at his post in Jammu district.

1. Illegally detained APHC vice chairman Shabbir Ahmed Shah has called upon the world community, particularly the United Nations, to play its role in preventing the ongoing bloodbath unleashed by Indian forces in occupied Jammu and Kashmir. Shabbir Ahmad Shah in a message from New Delhi's notorious Tihar jail, which was released to the media in Srinagar, highlighted the grim situation in the held territory. He deplored that the Kashmiri youth were killed by the troops without any reason. The APHC leader said during the past couple of months, dozens of civilians, mostly young boys, were butchered in fake encounters staged by the Indian military and paramilitary forces across the Kashmir valley. Shabbir Shah maintained that the targeted killing of youth was a part of India's nefarious agenda to change the demography of the territory.
2. The hunger strike by incarcerated Kashmiri Hurriyat leader Muhammad Yasin Malik entered its third day, today in New Delhi's Tihar jail. Muhammad Yasin Malik had announced the hunger strike till death to push for legal demands such as fair trial and physical presence during court hearings. He started the strike on Friday, July 22.
3. Indian troops conducted a violent cordon and search operation in Rampora Qaimoh area of Kulgam district, today. The operation was jointly launched by Indian Army, paramilitary Central Reserve Police Force and police. In another incident, a teenage boy was injured when a landmine laid by the Indian troops exploded near the Line of Control in Jammu's Poonch district. The injured boy was hospitalized.
4. Senior Aam Aadmi Party leader Harsh Dev Singh in a statement in Jammu reiterated the demand for early restoration of democracy in Jammu and Kashmir. He asserted that the bureaucrats from outside the territory could not be the substitute to an elected set-up in IIOJK.
5. Mohammed Zubair, co-founder of the Alt News fact-checking portal, has said the Modi government wants to silence all voices of dissent. Mohammed Zubair who spent 23 days in prisons, in a media interview in New Delhi pointed out that he was, in fact, made an example for others.
6. Anti- Citizenship Amendment Act activist and Delhi riots accused Khalid Saifi's wife, Nargis Saifi has said that her husband is not in good health and demanded immediate medical assistance for him. Khalid is currently lodged in Mandoli Jail in New Delhi. KMS

1. Illegally detained senior leader of All Parties Hurriyat Conference, Nayeem Ahmed Khan, has deplored the indifferent attitude of the international community towards the sufferings of the oppressed people of Indian illegally occupied Jammu and Kashmir. Nayeem Ahmed Khan in a message from New Delhi's infamous Tihar Jail said the people of IIOJK have been facing the worst Indian state terrorism for the last over seven decades but the world has been watching as a mute spectator. He pointed out that the criminal silence maintained by the United Nations and world human rights organizations on the grim situation of IIOJK had emboldened India to continue with its brutalities on the Kashmiris. Nayeem Khan called for implementation of the UN resolutions to settle the Kashmir dispute without any further delay to save the Kashmiri people from the Indian wrath.
2. Kashmiri Hurriyat leader, Yasin Malik, is on a hunger strike in Tihar Jail against the denial of justice and fair trial to him by the Indian kangaroo courts. Yasin Malik, who was sentenced to life imprisonment by an Indian court on May 25, this year, in false cases registered against him, started his hunger strike on Friday morning.
3. The family members of illegally detained APHC leader, Abdul Samad Inqilabi, in a statement in Srinagar demanded his immediate release from Varanasi jail in the Indian state of Uttar Pradesh so that he can look after his ailing aged mother who is admitted to a hospital in Srinagar.
4. Narendra Modi-led fascist Indian government is hell bent upon Indianising IIOJK and eradicating the Muslim identity of the territory. In its latest move in this regard, the Modi regime has approved the renaming of public institutions after the Indian forces' personnel and prominent persons who were killed in various attacks in the territory.
5. An 18-year-old Muslim youth was killed after he was attacked by members of the Hindutva organization Bajrang Dal in Bellare area of Dakshina Kannada district of the Indian state of Karnataka. The deceased was identified as Masood.
6. Over 50 prominent personalities from Canada in their letters to the Indian President Ramnath Kovind and Chief Justice N.V. Ramana expressed concern over India's diminishing democracy. They called for immediate release of activist Teesta Setalvad and retired Indian Police Service officer, R.B. Sreekumar who were arrested for pointing to the role of the then Chief Minister, Narendra Modi, in 2002 anti-Muslim riots in the Indian state of Gujarat. Teesta Setalvad also challenged in the Indian Supreme Court the Special Investigation Team's clean chit to 64 people, including Narendra Modi, in the riots case. KMS
